Corrections Corner

This space is dedicated to the corrections community — and to be used as a message board to anyone interested in this type of service work.

First, I want to thank Ralph T., for the excellent job he did as Area 46's Corrections Chair. I am certain he'll maintain that high degree of excellence as he goes on to serve Area 46 as Delegate. Good luck, Ralph! With that said, here's my first contribution to the Corrections Corner of this issue of the Pass It On Newsletter.

I've been thinking. (When I was working, I had a woman supervisor, and whenever I would go into her office and announce, "I've been thinking," she would ask me, "Did it hurt?") Anyway, here's an idea I've been "stewing about" for a long, long time: What if the Albuquerque Central Office had a Steering Committee position—titled Corrections Something or Another—that had a job description that went something like this:

Coordinate and/or facilitate the work of individual A.A. members, groups, and districts who are interested in carrying the A.A. message of recovery to alcoholics incarcerated in the Albuquerque area, and set up means of smoothing the way from the facility to the larger A.A. community through prerelease contact. (Please note, I took most of the wording for this job description directly from the A.A. Guidelines on Corrections Committees.)

I've been going to a jail meeting for over 10 years, and at one time I also served on the Central Office Steering Committee. As a result, I know a little bit about both service entities. What I also know about Albuquerque is that the local prison and jail facilities are usually not located in the same districts as those to which most Albuquerque AAers belong. For example, when I belonged to a group that was part of District 12, I was attending a jail meeting that was physically located in District 11.

The greater Albuquerque metropolitan area has a glut of correctional facilities in its midst, including several nearby county jails, three prisons in the South Valley, the Metropolitan Detention Center (MDC) on the West Mesa, a Federal facility in Albuquerque, several youth facilities, a new women's facility, and a renovated long term facility on the north West Mesa. Regular AA volunteers—and potential volunteers—are scattered throughout the metropolitan area in six districts—and one Spanish Intergroup (Oficina Intergupal)—that serve the greater Albuquerque metropolitan area. It seems to me that the Albuquerque Intergroup, through its Central Office, might do a better job of matching its resources; that is, its volunteers, literature, and phone service, to these burgeoning institutions if there was some "umbrella" entity, such as the Intergroup, that would coordinate all of the local correctional activities in and around Albuquerque. In short, if we had a Central Office Steering Committee member who would regularly meet, collectively, with the six, district-correction-committee chair people (Districts 3, 11, 12, 13, 17, and 18) and the Area Corrections Chair; namely, me, then we possibly could become more effective at carrying the AA message to the incarcerated people who need to hear our message. What do you think?

Principles Before Personalities

from Clearwater, Ontario

WHEN I ATTENDED my first AA meeting four years ago, I was immediately attracted by the principle of anonymity. Despite the fact that my life had become unmanageable and I was in pain, there still remained a vestige of pride that kept me from wanting anyone to know who I was or what I did for a living. You see, I am in elementary school teacher.

Alcohol had beaten me down to a point where I was morally and emotionally bankrupt, and this didn't sit well with what I believed to be society's accepted ideal of a teacher of young children. I was acutely conscious of the fact that I was a creature beneath contempt.

But in AA, I could keep my identity a secret. It wasn't long, however, before my anonymity was threatened.

One night a couple of months after I'd been introduced to AA, a member of my home group approached me and declared, "I finally figured out who you are." I had taught her son a few years previously and she had just now recognized me. Initially, I was disturbed by this discovery, but after talking with her, I relaxed and soon forgot that I was her son's teacher and felt the friendship of one AA member for another.

As I attended a wider range of meeting places, I eventually met other members whose children I was presently teaching, and it became easier and easier to approach them, not in any professional capacity, but as a fellow AA.

Throughout this time I still carried with me one primary fear. Although I felt at ease talking with parents of my students within the Fellowship, I did have a fear of going to open AA meetings because I knew some of my pupils attended these meetings with their parents. I feared that my alcoholism would become a matter of public attention if ever I was seen at an open meeting. This then has been the motivation for me to attend mostly closed meetings in AA during the last few years.

Last December I was on call for the AA answering service when I received a Twelfth Step request from a man to take him to an AA meeting on the following night. Unfortunately for me, the meeting the next night was an open meeting, and I was faced with the old dilemma.

I told this caller that I would have to get back to him, and I pondered what to do. I was scared that my valued principle of anonymity would be threatened. Dare I take this man to an open meeting and risk seeing a student? Should I refer the newcomer to someone else for help?

The next night I picked up my new friend and went to the open meeting, feeling anxious about what would happen. I was not in the meeting for more than ten minutes when I heard, "Hello, Mr. T." Turning around, I faced two of my students. Well, the sky didn't fall down, and they didn't ask me what I was doing there. We talked briefly and then parted as the meeting got started.

What these students of mine decide to do with their knowledge about me is beyond my control. Perhaps I don't give them enough credit for understanding AA principles even though they have parents actively involved in the program.

What I did learn from this entire episode was something about anonymity as it affects me. Our Twelfth Tradition states: "Anonymity is the spiritual foundation of all our Traditions, ever reminding us to place principles before personalities." Prior to this open meeting, there was little of a spiritual nature in my understanding of anonymity. Certainly my personality had priority over the principle of service. It was that night when I began to see how anonymity as the spiritual foundation of my AA program is there not to protect me from you but to protect me from myself.
