**Step 6** Were entirely ready to have God remove all these defects of character.

**Tradition 6 (Short Form)** An A.A. group ought never endorse, finance, or lend the A.A. name to any related facility or outside enterprise, lest problems of money, property, and prestige divert us from our primary purpose. **(Long Form)** Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into business. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A.- and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one.

**Concept 6 (Short Form)** The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board. **(Long Form)** On behalf of A.A. as a whole, our General Service Conference has the principle responsibility for the maintenance of our world services, and it traditionally has the final decision respecting large matters of general policy and finance. But the Conference also recognizes that the chief initiative and the active responsibility in most of these matters should be exercised primarily by the Trustee members of the Conference when they act among themselves as the General Service Board of Alcoholics Anonymous.

# Letter to the Editor

## Notes from the El Centro Group For the Pass It On Newsletter, June 2014

The El Centro Group Steering Committee exercised the Fourth Tradition (Group autonomy... "On such issues our common welfare is paramount"... ) by passing a motion at the April Business Meeting ending the signing of Court Papers and anything similar to them at its meetings, effective May 1. The El Centro Group meets three days a week at 7:30 on Monday, Wednesday and Saturday and all are Open Meetings, everyone is welcome, particularly the newcomers, but we ask that only alcoholics share at our meetings. We passed this motion because we feel that signing court papers is in violation of some of the Traditions and obstructing AA unity as a whole. Tradition Six reads "While an AA group may cooperate with anyone, such cooperation ought never go so far as affiliation or endorsement, actual or implied". We don't want to be affiliated with the Court System. Tradition Seven states that "that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source, or of contributions carrying any obligation whatever, is unwise". The courts are sending people to our meeting who don't identify as alcoholics, yet they put money in the basket, we can't question everyone who contributes to the 7th Tradition. Tradition Ten says, "No A.A. group or member should ever, in such a way as to implicate A.A., express any opinion on outside controversial issues—particularly those of politics, alcohol reform, or sectarian religion". Some people, in and out of AA consider the signing of Court Papers as a requirement for probation, to be a controversial issue; we don't want any part of it. Tradition Eleven tells us that "Our relations with the general public should be characterized by personal anonymity..... Our public relations should be guided by the principle of attraction rather than promotion". Some people with Court Papers announce at required group counseling meetings that they attend AA meetings, breaking their anonymity and we don't want our meeting or AA promoted through the Judicial System. Finally, the El Centro Group doesn't want to prevent potential alcoholics from experiencing the consequences of their actions, we don't enable at the El Centro Group.

# Spiritual Experiences vs Awakening

(Part II - Part I was in May 2014 Pass It On)

Well the first day in mid-October 2011 with “no thought” went well. I stood next to my dining room table enjoying the beauty of my tree. I don’t know how long I was able to be free of thought, but I’m sure it wasn’t many minutes. I did achieve a sense of peace but no relief from my anxieties.

The next day with anticipation of my Higher Power’s presence and healing, I stood again in my dining room admiring the beauty of my tree. Then I started tingling from head to toe as joy was building up in my chest. I laughed and I cried as my chest filled with so much love that it felt that it might burst. I experienced the sense that my chest extended far outside of my physical body. I said, “You are real, you really are!” I realized as I said it how stupid that sounded, of course God is real! I continued to laugh with tears streaming down my face. As the sensations subsided the sense of joy and love remained. I knew I was different. As it says in the Big Book, my whole attitude and outlook on life had changed.

It took a while to register what had happened. I still experience the tingles frequently and have peace of mind. I noticed within a few days that my anxieties were gone. I found that I was no longer interested in spending time in thoughts of the future or the past. I saw that the present is all there is. Time revealed that I was restored to a sanity that I had never experienced. I had to wonder laughingly if I got a reboot to my original birth setting.

Shortly after the experience, I could see how selfish I had been in so many different areas. But I have to say that this observation was from a loving place and carried no judgment. My greatest desire was to make amends to my children, whom I had given my opinions too freely. Now I am supportive. I don’t know what is best for anyone; everyone has their own path. My job is to listen and love. If anyone asks for guidance, I make certain that I am grounded in Source.

I had a spiritual experience that healed my mind and woke me from my illusions and distorted thinking; thus I had a spiritual awakening. Now rather than a day at a time, I live a moment at a time. I now experience the eleventh step. My Source directs my thoughts and actions today because I chose it. I still have free will.

My thinking is on a much higher plane; it is purpose driven. I only think when I need to and if I want to stop thinking to enjoy the moment, I can. I am not seeking anything, since I am living what I always sought. Now I help teach my sponsees how to live in the moment. It seems that my soul’s purpose has always been to connect to Higher Power.

I also feel connected to others and love being around people. I still have a little ego left and it tries to take me for a ride occasionally, but it doesn’t last long. I like to picture my ego as sitting in the corner of my mind and every now and then I have to throw it a bone.

At 72 years old I feel young and truly alive. You can catch me giggling for no reason or exclaiming quietly before a meeting starts, “I love this meeting!” A sense of joy keeps arising from within me. I only have to be truly present to be joyful and filled with love and peace. My addiction to MY thoughts is replaced by the sounds of nature or of the world. I wrote the following in 1992 with HP’s direction. I now live it.

Just for today I will: stay in the present; make no judgments; make no expectations; not need to know why; relax in the silent assurance that I am not running this show; watch thoughts of judgments, expectations, and the like, pass as clouds, knowing they have nothing to do with me.

I made the “Just for Today” into wallet cards and 5x7 placards to give to sponsees and friends. Use it if you like. (More shall be revealed in my next article.)

If a mere code of morals or a better philosophy of life were sufficient to overcome alcoholism, many of us would have recovered long ago. But we found that such codes and philosophies did not save us, no matter how much we tried. We could wish to be moral, we could wish to be philosophically comforted, in fact, we could wish these things with all our might, but the needed power wasn't there. Our human resources, as marshaled by the will, were not sufficient; they failed utterly...Lack of power, that was our dilemma. We had to find a power by which we could live, and it had to be a Power greater than ourselves. Obviously.

Question made as to whether the 4% charge might be added to lit. to absorb the cost , "time will tell"

**Central Office Coordinator** Will go to Roundup to share information regarding Central Office. Been requested he go to Corpus Christi to do something similar. Made an order of 100 more of the 75th edition, after the initial purchase of 200. We've had a really strong month. Report regarding lit sales, will be make a sales report for the last 6 months of sales. Shift coverage needed every Saturday from 9-12 am. Comments: Questions regarding the possibility of raising prices, will that possible decision be made at intergroup or by the Steering Committee? Michael: Probably at steering group, taking into account the input of intergroup reps. Raising prices is the last thing we want to do, but it may happen. Prices, historically based upon how financially solvent we are. They could conceivably go lower, if sales get better. Questions regarding pricing of Grapevine. No definite info available.

In such circumstances, upon occasion, Debra or Michael have worked up to 12-13 hours shifts should desk worker not make it. It has also occurred, though not frequently, that they have had to rush back to the office in such an instance. Last month Michael covered 6 shifts, Debra 5, for those who didn't make their shift. Ongoing problem with people calling with very little notice to say they couldn't cover their shifts.
