Step 8 Made a list of all persons we had harmed, and became willing to make amends to them all.

Tradition 8 (Short Form) Alcoholics Anonymous should remain forever nonprofessional, but our service centers may employ special workers.

(Long Form) Alcoholics Anonymous should remain forever nonprofessional. We define professionalism as the occupation of counseling alcoholics for fees or hire. But we may employ alcoholics where they are going to perform those services for which we might otherwise have to engage nonalcoholics. Such special services may be well recompensed. But our usual A.A. "12 Step" work is never to be paid for.

Concept 8 (Short Form) The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active Services, exercising this through their ability to elect all the directors of these entities.

(Long Form) The Trustees of the General Service Board act in two primary capacities: (a) With respect to the larger matters of over-all policy and finance, they are the principal planners and administrators. They and their primary committees directly manage these affairs. (b) But with respect to our separately incorporated and constantly active services, the relation of the Trustees is mainly that of full stock ownership and of custodial oversight which they exercise through their ability to elect all directors of these entities.

The Trustees of the General Service Board act in two primary capacities: (a) With respect to the larger matters of over-all policy and finance, they are the principal planners and administrators. They and their primary committees directly manage these affairs. (b) But with respect to our separately incorporated and constantly active services, the relation of the Trustees is mainly that of full stock ownership and of custodial oversight which they exercise through their ability to elect all directors of these entities. This Concept deals with the ways the General Service Board "discharges its heavy obligations," and its relationship with its two subsidiary corporations: A.A. World Services, Inc. and the A.A. Grapevine, Inc.

Long experience has proven that the board "must devote itself almost exclusively to the larger questions of policy, finance, group relations and leadership In these matters, it must act with great care and skill to plan, manage and execute." The board, therefore, must not be distracted or burdened with the details or the endless questions which arise daily in the routine operation of the General Service Office or the publishing operations, including the Grapevine. "It must delegate its executive function" to its subsidiary, operating boards.

So the trustees don't sweat the small stuff. "Here, the board's attitude has to be that of custodial oversight The trustees are the guarantors of good management of A.A. World Services, Inc. and the A.A. Grapevine, Inc. . . . by electing the directors of these service arms, a part of whom must always be trustees The executive direction of these functions is . . . lodged in the . . . service corporations themselves, rather than the General Service Board. Each corporate service entity should possess its own bylaws, its own working capital, its own executives, its own employees, its own offices and equipment." Bill draws from earlier mistakes by the General Service Board in trying to run the service functions directly and warns repeatedly against "too much concentration of money and authority."

SERVICE WORK

07/16/2013 My name is Melissa and I am an alcoholic. Today I have 196 days of continuous sobriety. I am writing because I want to express my love and gratitude for Alcoholics Anonymous and tell you why I love AA's events and activities.

In February of 1996, insane, totally terrified, degraded, humiliated and desperate, I ran from my life in Albuquerque, NM back to my home in California to live with my sister and to get sober. Within the first week of arriving I was going to meetings. At the first women's meeting I attended I heard a woman speak. Her name was Claudette, she was Egyptian, she had 10 years of sobriety, and she was telling my story. I was floored. The people I knew and had been around for so many years never spoke so candidly, openly or as honestly as Claudette was doing. I couldn't stop staring at her and I couldn't stop crying.

When the meeting finished I followed her out to her car and begged her to be my sponsor. At first she told me no, she was too busy; she was working on a convention and didn't have time for me. I told her I would do anything, anything, just don't leave me here alone, just help me. I was so desperate! Finally she looked at me and asked, "Anything?" "Yes, anything!" I said. She told me to get in her car and we were off. When she let me in the front door of her house I was blown away, it looked like a craft store had exploded in her living room. She then told me that the last girl she sponsored had just fired her and left her to decorate the banquet hall of the San Fernando Valley AA Convention by herself. She had 60 or 70 tables to create centerpieces for, banners and balloon bouquets and name tags and place cards to create and one week to do get it all done. The convention was that weekend. She asked me again, "Are you sure you are willing to do anything?" I agreed, anything. For a week, every evening, we worked. I did everything she asked of me. And during that week we talked. She told me her story, everything she didn't share from the podium and I told her my story. We worked and talked late every night.

Finally, the morning of the event, when we had managed to get all of the work done, we went to the banquet hall and started decorating, using everything we had made together. I cried the whole morning, and as tough as Claudette was, she did a little too! After we had decorated the hall and everything was ready, we got into her car and she said, "I have a surprise for you..." She took me to the mall and bought me a new dress and shoes and a handbag to match. Then she gave me a ticket to the banquet and told me I earned a seat at her table. I attended the banquet with her, and it turns out I was the newest member in recovery that night. I got the big book and what seemed like a thousand hugs and kisses and well-wishes!

Nothing will ever take away the memory of that night, or the week leading up to it. Nothing will ever take away my memories of or my love for Claudette. Every time I am involved in the planning of an event I do it for her, I do it because she saved my life. She was the first to set the example of service work for me and never in a million years can I ever repay that debt to her. She made me feel accepted, important, welcomed and part of the family of Alcoholics Anonymous and some day I hope I have the honor of passing it on to another alcoholic like myself.

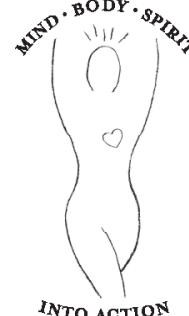

Treasurer's Report June and July have been slow for sales and group contributions. Michael is closely watching the inventory and only keeping what is necessary in stock. Total revenues: \$5,862.88 – Cost of Sales: \$2,665.33 – Gross Income: \$3,197.55 – Expenses: \$4,994.36 – Net Income (\$1,796.81) – Net Income YTD (\$2,095.78)

Central Office Coordinator Michael reported that the Central Office picnic was well supported, and volunteer contributions by groups kept our expenses down. The desk has had a lot of support from substitute workers, with many regular workers going on summer vacations. He thanked the outgoing Alternate Coordinator, Pam for her work at the office over the last year and announced that Debra K. will be the new Alternate Coordinator and will start on August 1, 2013. Michael then stated that he is planning a 12th step workshop and am assembling a panel of people with experience in using social media in 12th step work. The workshop will be August 17 at Asbury Methodist Church. Anyone with experience in using social media in 12th step work, please contact him. There is an Intergroup Speaker Meeting on July 27 at Jemez Springs Presbyterian Church hosted by District 18.

Alternate Central Office Coordinator Pam thanked the Intergroup for allowing her to be of service over the past year. She added that there is a Saturday desk shift open from 3 – 6 PM, and that weekends are when substitute workers needed most. There were 778 Calls, 260 Walk-ins, 3,470 web hit reported for the month.

Member at Large Debra K. thanked the group for the opportunity to serve as Member at Large, and noted how much she appreciated the position. However, as Michael stated, she is happy to be transitioning to the Alternate Coordinator position as of August 1st. She reported that she placed the ad in the Alibi – the cost was \$3.12.

Pass it On Editor Steve informed the group that extra issues of PIO were appreciated at the Taos convention. Birthday submissions are doing well, as have regular submissions. He asked again for article submissions for the PIO, otherwise he will have to keep running re-prints. Articles should be 300-500 words approximately.
