Step 8 Made a list of all persons we had harmed, and became willing to make amends to them all.

Tradition 8 (*Short Form*) Alcoholics Anonymous should remain forever nonprofessional, but our service centers may employ special workers. (*Long Form*) Alcoholics Anonymous should remain forever nonprofessional. We define professionalism as the occupation of counseling alcoholics for fees or hire. But we may employ alcoholics where they are going to perform those services for which we might otherwise have to engage nonalcoholics. Such special services may be well recompensed. But our usual A.A. Twelfth Step work is never to be paid for.

Concept 8 (*Short Form*) The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities. (*Long Form*) The Trustees of the General Service Board act in two primary capacities: (a) With respect to the larger matters of over-all policy and finance, they are the principal planners and administrators. They and their primary committees directly manage these affairs. (b) But with respect to our separately incorporated and constantly active services, the relation of the Trustees is mainly that of full stock ownership and of custodial oversight which they exercise through their ability to elect all directors of these entities.

WHAT IS CENTRAL OFFICE?

The idea occurred to several of us that it might be a good idea to describe what Central Office (CO) is and some of the services it provides. One thing that needs to be explained upfront is that for our purposes Intergroup and Central Office are both part of the same organization structure.

Below you will find the definition of Central Office as provided by The General Service Office (GSO) in New York:

A central office (or intergroup) is an A.A. service office that involves partnership among groups in a community - just as A.A. groups themselves are partnerships of individuals. A central office is established to carry out certain functions common to all the groups - functions which are best handled by a centralized office - and it is usually maintained, supervised, and supported by these groups in their general interest. It exists to aid the groups in their common purpose of carrying the A.A. message to the alcoholic who still suffers.

designed to do. More specifically Central Office provides literature to the groups it serves, generally, at a lower cost than if an individual group attempted to purchase literature from GSO. In addition to literature Central Office provides a dedicated telephone for the purpose of providing 12 step services, information about meetings and other AA related events.

Central Office is governed by The Albuquerque Intergroup, which is a registered group of Alcoholics Anonymous. The group consists of 13 steering committee members and group representatives from the groups in the Albuquerque area. The Central Office is operated by two paid workers who are also steering committee members. Additionally volunteers man the phones and serve as desk workers to assist individuals who call or walk in to CO. Central Office also publishes this newsletter. Most of the services provided by Central Office require the assistance of volunteers. The paid worker's salaries are provided through monies received from sales of literature and from contributions from the area groups and individual AA members. It should be noted that the steering committee acts and exists at the behest of Intergroup. The quality of service increases as group participation increases via intergroup representatives. It is the groups that determine how Central office is run. It is important to always remember that in Alcoholics Anonymous the group is the strongest link in the chain and without groups there would be no Alcoholics Anonymous

The existence of a Central Office in a large metropolitan area such as Albuquerque is an important and indispensable part of carrying the message to the still sick and suffering alcoholic. Service is an important part of the AA legacy and Central Office is an important part of the service structure.

CENTRAL OFFICE NEEDS REGULAR AND SUBSTITUTE DESK WORKERS

Requirements for this service opportunity are six months of sobriety, a sponsor and a home group. A

desk shift at Central Office can enhance your sobriety. It can broaden your view of the service structure of your group, your district and your area. And it's fun! Call Central Office today at 266-1900.

TRADITIONS 4 AND 5 by David G.

Traditions 4 "Each group should be autonomous except in matters affecting other groups or AA as a whole." and Tradition 5 "Each group has but one primary purpose-to carry its message to the alcoholic who still suffers."

These traditions have had a major impact on my life and my sobriety because of the place they have in my Homegroup. We are a closed men's group of Alcoholics Anonymous in Albuquerque, NM.

We started on July 4th, 2002, with about 7 or 8 men who didn't know each other all that well. Now we often get between 40 and 60 men at our weekly Thursday night meeting. Probably half of those fellows know each other very well.

We have, by group tradition, always been autonomous. We do not do a lot of things that a lot of other groups do, such as the automatic Circle of Love donations, Grapevine subscriptions, and birthday announcements in newsletters, etc. We probably buy a case or three of mini Big Books every year from Albuquerque Central Office. We give them to any man who wants to pick it up with a smiling suggestion that they read the black part. We have a relationship with the Good Shepherd Shelter for the Homeless. For several years now we have taken a meeting into that facility and we share that commitment with another Men's group. Now there are 10 or so of the residents attending our meeting on Thursday as well and some more men who have become "alumni" of the Good Shepherd.

The weekend after July Fourth we have our annual Retreat and cook-out in the Jemez mountains. We have a meeting and it is usually one of the best of the year. In the fall we have another cookout and picnic in the Sandias for the whole family so that our loved ones can see what we look like. Bill B. brought these traditions to us from his old home group in Michigan; it seems to be working for us here. We have found it best to let our friends recommend us.

Central Office encourages all groups to elect an Intergroup representative. Join us at the next Intergroup meeting the second Sunday of every month, at 2 pm, at the Brownbaggers.

2. Anonymous "As far as having a favorite Tradition or one that means the most to me, I would say that each Tradition is important on its own merit but combined together they are amazingly powerful principles that unify us as a Fellowship rather than as individuals. The longer I am an A.A. member in good standing, the more apparent this becomes."

A Few Thoughts On Service

I see fewer and fewer newcomers becoming of service to the AA program. I wonder why that is? Is it because of the phrase we hear in meetings that this is a program of suggestions? That no one came 'make' you do something if you don't want to? To some degree, that's so. I believe that it is the sponsor's responsibility to direct a sponsee to get a service position. Whether that person does or not is their decision. The sponsor introduces, and leads by example, in service work. The sponsee is responsible for the quality of their sobriety. The service I have done in my sobriety has only enhanced it. It was not suggested that I do service – I was directed to find a service position. The work required in working the Steps is not suggested. Why else the phrase 'Good Orderly Direction'? The difference between a suggestion, and a direction, is clear. "If you want what we have, and are willing to go to any length to get it – then you are ready to take certain steps" I was challenged several times in early sobriety to remember that I had agreed 'to go to any length', but the decision was mine to make, ultimately. My fear of returning to drinking is what stopped me from saying 'No Thanks...maybe later'. I might not have a 'later'.

It is stated in 'The Doctor's Opinion' that we work on an altruistic plane. Altruism is defined as 'feelings and behavior that show a desire to help other people and a lack of selfishness' (Merriam-Webster). I define it as giving back to the program that is saving my life, everyday. If I am not being of service on a regular basis, I fall into the same old selfish pattern of thinking of only me. This program

is not about me, it is about what I can do to help the next suffering alcoholic, and that is sometimes doing the thankless business of doing the groups chores. (or the districts, or the Area's, or the workshop, etc.) Look around-is there a 'core' group of people in your home group who do all the chores? Is it because you are not stepping up to do your part? If I work 'my program' of AA, I get into a lot more trouble than I do if I work THE program of Alcoholics Anonymous. Half measures avail me nothing.
