Concept 9: "Good service leaders. together with sound and appropriate methods of choosing them, are at all levels indispensable for our future funcioning and safety. The primary world service leadership once exercised by the founders of A.A. must necessarily be assumed by the Trustees of the General Service Board of Alcoholics Anonymous."

No matter how carefully we design our service structure of principles and relationships, no matter how well we apportion authority and responsibility, the operating results of our structure can be no better than the personal performance of those who must man it and make it work. Good leadership cannot function well in a poorly designed structure...Weak leadership can hardly function at all, even in the best of structures. A leader in A.A. service is therefore a man (or woman) who can personally put principles, plans and policies into such dedicated and effective action that the rest of us want to back him and help him with his job. Good leadership will also remember that a fine plan or idea can come from anybody, anywhere. Consequently, good leadership will often discard its own cherished plans for others that are better, and it will give credit to the source. Good leadership never passes the buck. Once assured that it has, or can, obtain sufficient general backing, it freely takes decisions and puts them into action forthwith, provided of course that such actions be within the framework of its defined authority and responsibility. Our leaders do not drive by mandate, they lead by example. We say to them, "Act for us, but do not boss us." -12 Concepts for World Service **Illustrated**

ALBUQUERQUE INTERGROUP GROUP INVENTORY AUGUST 14 2011

The Albuquerque Intergroup meets monthly on the second Sunday at 2:00pm at the Brownbaggers location (just off Montgomery and San Pedro). Following the next meeting on August 14, the Intergroup will begin a Group Inventory process. The Group Inventory will begin about 3:30pm and end no later than 5:30pm. It is possible that it will require a second session to complete the inventory and that decision will be made on August 14th.

A Group Inventory is a sharing session, no business is conducted and no votes are taken. The A.A. Service Manual defines a "sharing session" as follows (2010-2011 edition, page S40).

"In a sharing session, everyone has a chance to use their experience, strength and hope to contribute ideas and opinions about the welfare of [the Albuquerque Intergroup]. Its format is aimed at drawing out the ideas of even the shyest participant, and keeps the more articulate from dominating the meeting. Each person offers an opinion, and never needs to defend it. The chairperson or leader functions more as a timekeeper than as a participant. Here is how it works:

"The leader, armed with a loud bell and a watch or stopwatch, reads the question and explains the rules. Each person present may talk for a specified time (a minute and a half or two minutes is typical -- whatever the group agrees upon). Usually no one is permitted to speak twice on the same subject until all who wish to have spoken. The leader continues until the topic has been fully explored.

"A member takes down the essence of the meeting; these notes will provide good ideas for use by committee officers and members."

The Albuquerque Intergroup has developed the following questions for the Group Inventory. These questions relied on the standard list of 13 questions for a Group Inventory contained in The A.A. Group pamphlet (p-16). It is possible that these questions will spawn additional questions which will be covered once the following questions have been fully explored.

Group Inventory Questions

The term "group" means the Albuquerque Intergroup (IG) and the Albuquerque Intergroup Steering Committee (SC).

- What is the basic purpose of our group(s)? Are both IG/SC groups guided by the Steps (Recovery), Traditions (Unity), and Concepts (Service) in contributing to the purpose of A.A.?
- 1.1 Groups carry the message of the solution, intergroup sets the policies, steering committee executes those policies.
- 1.2 Yes. We make 12 step work possible.
- 1.3 Has a lot to do with central office and the groups input on it.
- 1.4 Intergroup is the info hub.
- 1.5 Intergroup and steering committee foster 2-way information.
- Are we careful to preserve the anonymity of our group members and other AAs outside the meeting rooms? Do we preserve the anonymity of participants while sharing the results of meeting discussions with our home groups?
- 2.1 Yes we are preserving anonymity.
- 2.2 Anonymity is not for in AA, but for outside AA.
- 2.3 Lets not be too anonymous, it's each persons choice to use their names (first and/or last)
- 2.4 It is important to not share names of people from IG.
- 2.5 Made efforts to keep peoples names anonymous on web.
- 2.6 Good to hide e-mail addresses
- IG Representatives from Districts and Groups ... Do new IG members stick with us, or does the turnover seem excessive? How can we boost lagging attendance at meetings?
- 3a.1 It's not the turnover, but the participation. Helps to give people a job.
- 3a.2 Once people come they feel more comfortable.
- 3a.3 Time of month is sketchy. Announcement/reminder would help.
- 3a.4 A lot of "dark groups"
- 3a.5 Some groups have no idea what IG does and how it relates to them.
- 3a.6 We tried to incorporate IG to service structure.
- 3a.7 Michael is coming to our district to talk about IG.
- 3a.8 E-mail reminders were helpful.
- 3a.9 Put date of next IG meeting in Pass it on.\
- 3a.10 Bring Cookies.
- 3a.11 Outreach to "dark groups"
- 3a.12 Instead of an Activities chair, how about an Outreach chair.
- 3a.13 IG, District, and Area help groups practice the traditions.
- How can we transmit enthusiasm for service and participation?
- 3b.1 It's on a personal level.
- 3b.2 Speaker meetings help.
- 3b.3 When I isolate I get sick; when a group isolates it gets sick too.


